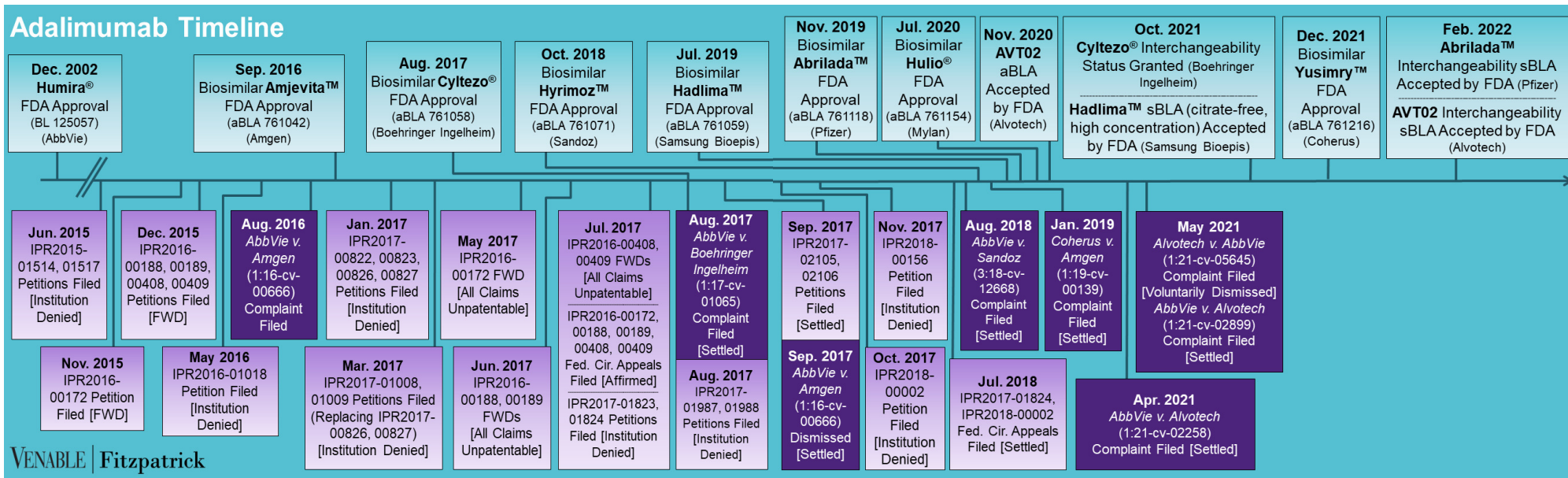
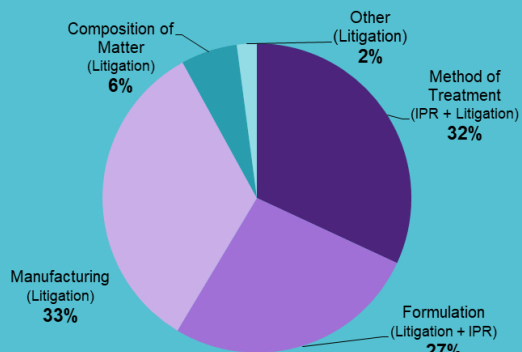

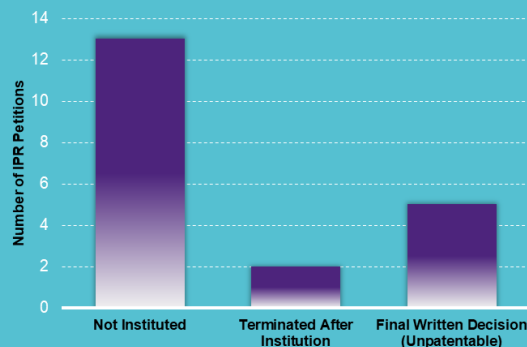
## Adalimumab Challenged Claim Types in IPR and Litigation\*



\*In litigations, it has been alleged that at least these claims will be infringed.

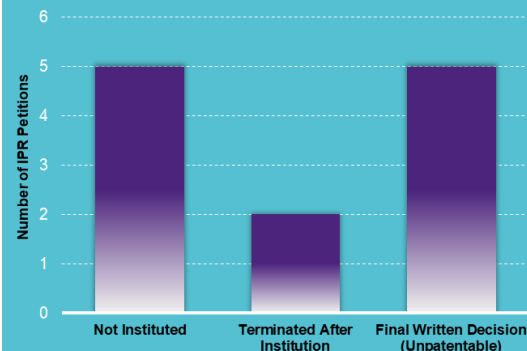

## Adalimumab IPR Status



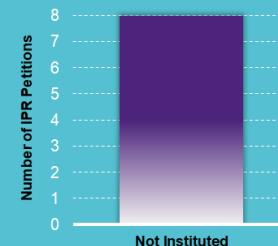

# Spotlight On: Adalimumab

**Technology:** Adalimumab is a human monoclonal antibody that inhibits tumor necrosis factor alpha (TNF $\alpha$ ). TNF $\alpha$  is a cytokine cell signaling protein that is involved in the inflammatory response that occurs in autoimmune diseases.
