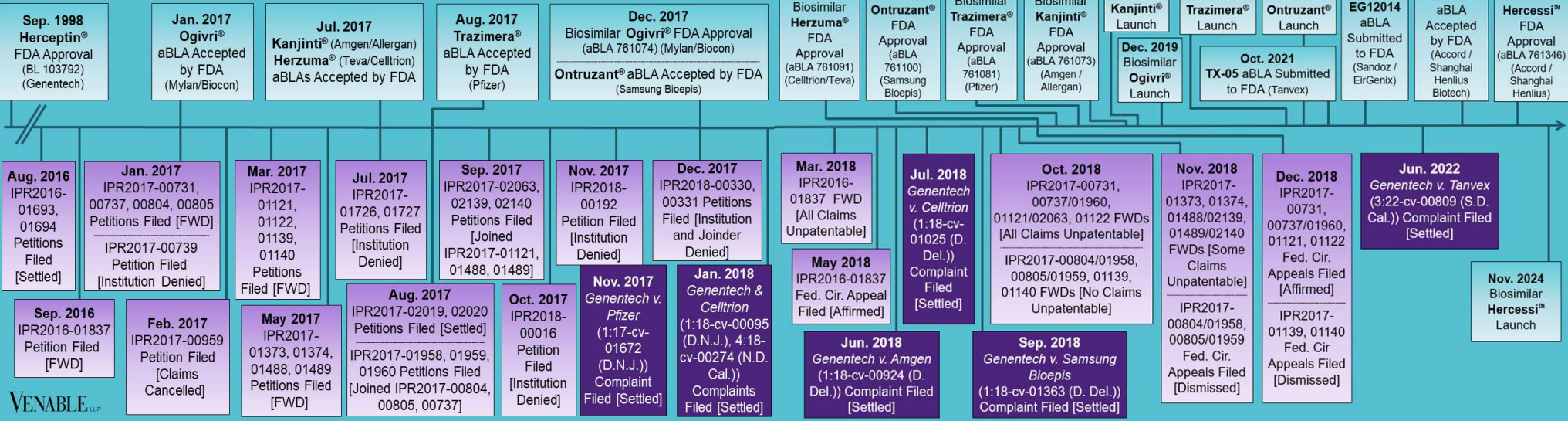


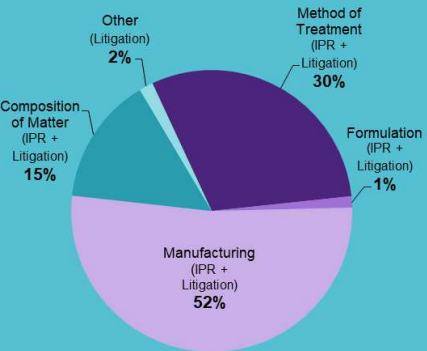

Trastuzumab Timeline

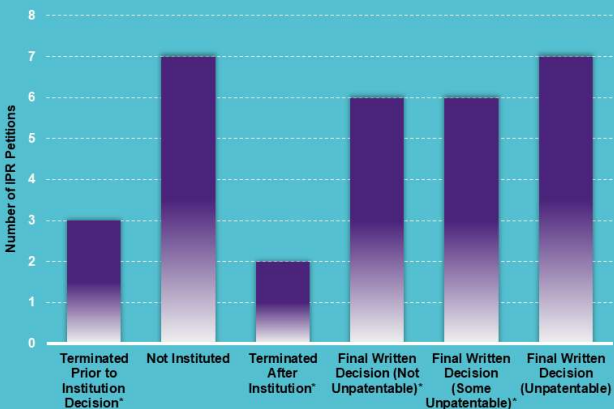


Trastuzumab Challenged Claim Types in IPR and Litigation*



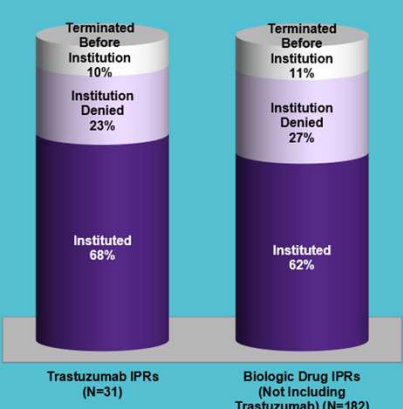
*In litigations, it has been alleged that at least these claims will be infringed or are invalid.
