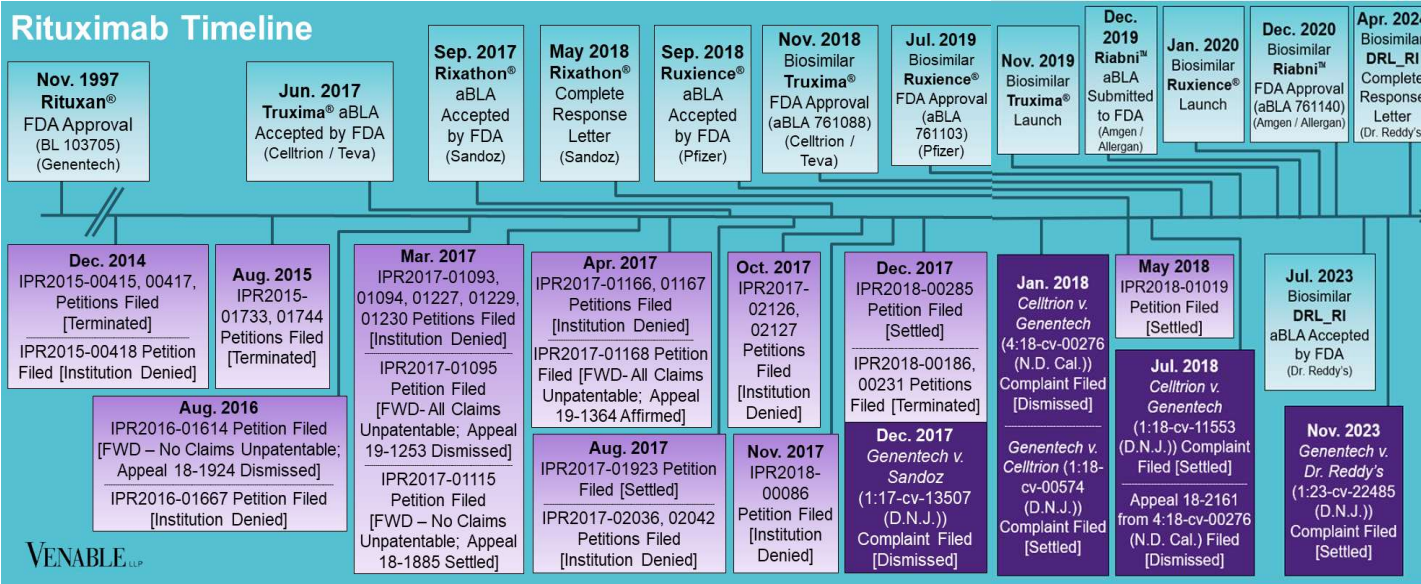
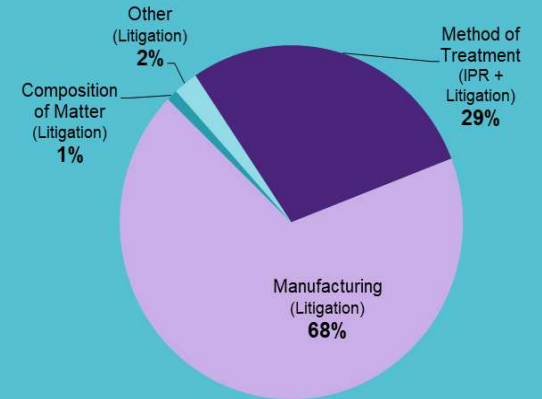

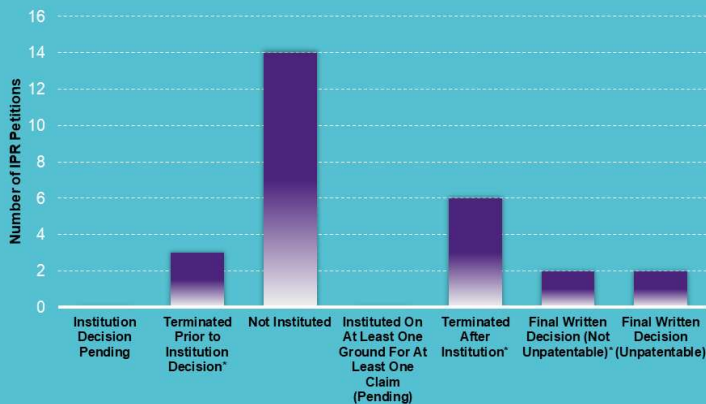


## Rituximab Challenged Claim Types in IPR and Litigation\*



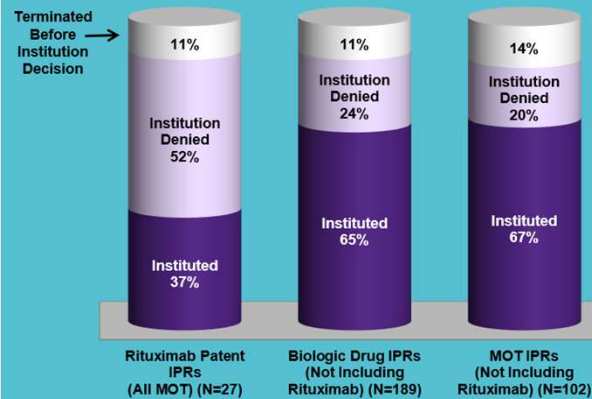
\*In litigations, it has been alleged that at least these claims will be infringed.

## Rituximab IPR Status (All Method of Treatment Claims)



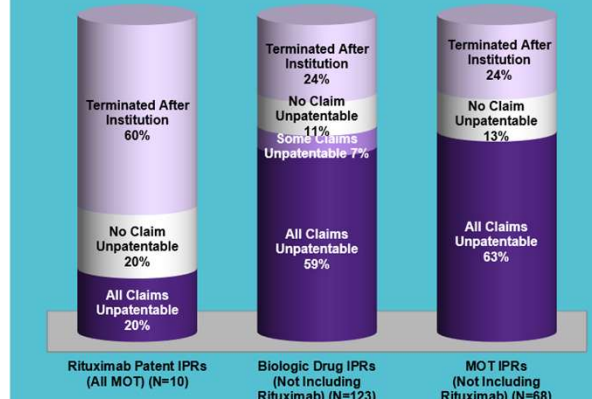
