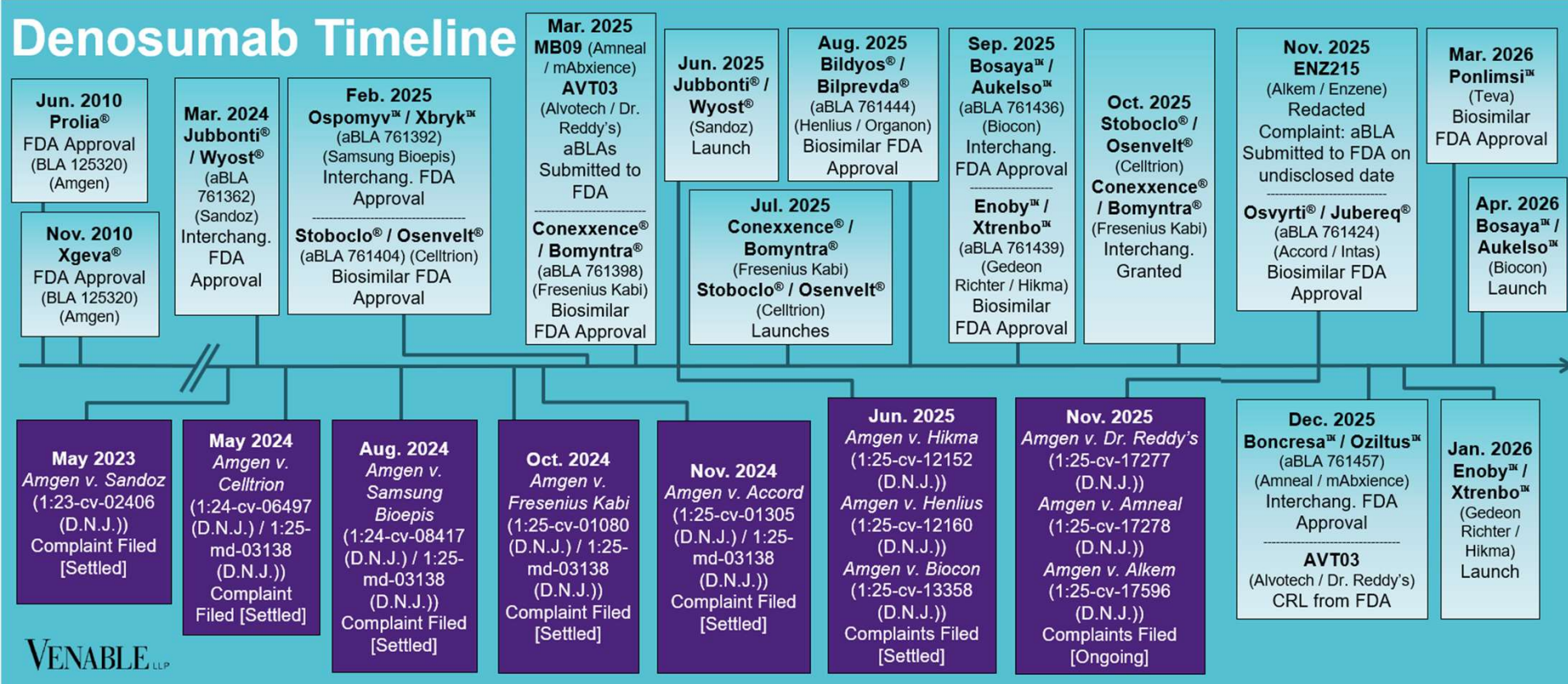


Technology: Denosumab is a human monoclonal antibody that binds to the RANKL protein on osteoclasts (cells that break down bone), inhibiting their formation, function, and survival, which regulates bone turnover by slowing bone resorption.
